## GREETINGS TO ALUMNI

Charles F. Deiss

Among the most satisfying rewards for the Chairman of the Geology Department at Indiana University is the pleasure constantly experienced in meeting and talking with the graduates of the Department. The stimulus that results from contacts with vigorous men in the oil and mining industries, in the Geological Surveys and in geology departments is one of the major compensations offered by university life. To all of our alumni that I have talked with during the past year and to all of our other graduates with whom I have not had the privilege of talking recently, I take this opportunity to extend greetings on behalf of the geology faculty.

Recent intensification of public interest in the educational system of America, occasioned by the achievement of Russian scientists in placing the first satellite in orbit, is resulting in closer scrutiny of the entire educational system. This careful examination of our educational system doubtless will result in changes of emphasis on subject matter, increased scholarly standards, and new methods of instruction. During the past five years, the geology faculty here at Indiana University has been constantly seeking answers to these very problems. Consequently, we welcome the renewed interest in education, and the increased responsibility and growth of the Department of Geology that inevitably will result from it.

The increased interest of our alumni in geologic education was evidenced by a stimulating and serious discussion that lasted nearly two hours at an Indiana University breakfast in the Biltmore Hotel, Los Angeles, on March 11, during the annual meeting of the American Association of Petroleum Geologists. Although only nineteen persons were present, the enthusiastic and serious discussion combined with increased interest in the Geology Department made this the most significant ge-alumni gathering that I have attended in ten years. We in the Department learn much from such meetings. I take this opportunity to urge you to write to any of the faculty your ideas of how the Department of Geology can strengthen its courses and thereby make itself more useful.

Perhaps the most interesting new development in the Department since our sixth newsletter was sent to you about this time last year is the progress being made in planning the new geology building at Indiana University. On November 27, 1957, we received the first set of schematic building plans from the architects, Eggers and Higgins, in New York City. Several weeks later, a representative of the architectural firm spent four days with the

faculty and Survey scientists revising the plans. On February 15, we received the second set of plans which were greatly improved over the first attempt. During the week of March 17-22, the New York architect again visited the campus in a second comprehensive revision of the building plans. The University Administration expects to let bids and start construction of the building before the end of 1958. Although we cannot forecast the future, all indications now point to a new geology building being completed sometime between 1961 and 1963.

Again I invite you most warmly to visit the Department and campus whenever you can. As indicated in my last greetings, you also will receive a cordial welcome at our Geologic Field Station in the South Boulder Canyon near Cardwell, Montana, between June 25 and August 3.

I hope that this NEWSLETTER will again bring each of you new information about old friends and the Department. We send it to you with the best wishes of each of us.

#### FACULTY MEMBERS ON SABBATICAL LEAVE

Dr. Thomas G. Perry, Assistant Professor of Geology, is on sabbatical leave this semester (Spring 1957-1958). Professor Perry is on campus and devoting his attention to several research projects which include a systematic study of the bryozoan fauna of the Brownsport formation (Middle Silurian) of west-central Tennessee. Doctors T. G. Perry and D. E. Hattin have recently completed a study dealing with the astogeny of fistuliporoid bryozoans which indicates that members of this bryozoan clan undergo little structural change during their development.

Dr. William D. Thornbury, Professor of Geology, is also on leave this spring semester. Professor Thornbury and family are in Pomona, California. Bill, with office space at Pomona College, is writing a new text in the field of geomorphology. The Thornburys will be back at Indiana University for the fall semester, 1958.

#### LOST FACULTY MEMBERS

Dr. Haydn H. Murray, Associate Professor of Clay Mineralogy, resigned on May 31, 1957, to accept a position as Director of Research, Research Division, Georgia Kaolin Company, with headquarters at 433 North Broad Street, Elizabeth, New Jersey. #### NEW FACULTY MEMBERS

#### LOST STAFF

For those alumni who have not had contact with the Geology Department in the last year, it will come as sad news to learn that Ross Hickam, Department Preparator, passed away last summer. Ross suffered a stroke the morning of July 18 at the Geologic Field Station in Montana. He never regained consciousness. #### TEACHING ASSISTANTS

David R. Berendsen, Evansville, Indiana, A. B. Washington University, 1957. Dave's major interest is "soft rock" geology with a definite preference for paleontology. He plans to complete work for the A. M. degree in February 1959 and hopes to continue at I. U. for a Ph. D. in paleontology.

Gene is specializing in petrography and petrology and will undertake a thesis on "Wall rock alteration at Tonopah, Nevada" under the supervision of Professor Vitaliano. #### LIBRARY

The collections of the Indiana University  
Geology Department Branch Library continue to  
increase. As of March 15, 1958, the library  
contained approximately 22,000 volumes, an  
increase of 1,500 volumes over last year.

The collection of geologic and topographic  
maps also continues to expand. As we mentioned  
last year, the map collection was being classified  
for more convenient use. This classification is  
almost complete, and the maps are housed in a  
separate wing of the library and ready for use. At  
present we have 3,600 geologic maps plus topo-  
graphic maps of the United States and its possessions  
in the collection.

The library has just started a collection of  
separates or reprints. Some of these reprints are  
from journals already in the Geology Department  
Library. Many others are from journals that publish  
material of geologic information only incidentally.
